DECLARATION 1

I declare that I will maintain a minimum of £3,000,000 third party liability insurance on any craft that I own which uses the boat park, either permanently or temporarily. I confirm that this insurance will be in place from 01/01/2025 until 31/12/2025. In the event that I sell a craft I will advise the boat park manager and the membership secretary in order that an insurance declaration can be obtained from the new owner. I confirm also that I will ensure that should I bring a caravan, motorhome or trailer tent to the club site it will also have third party insurance. In the event of non-payment of berthing fees I understand that Glasson Sailing Club may pursue payment through formal legal channels.
